Sustainable Tourism.

9.24/100:

The Parish Council received correspondence from Visit Bude's Sustainable Tourism project, The Bude Way, which is funded by Bude Climate Partnership. They have asked for the Parish Council's support in furthering the campaign of the environmental impact of single-use disposable BBQs and cheap polystyrene bodyboards.

Campaign 1: Single-Use Disposable BBQs often end up causing injuries, fires, and leave sharp, hazardous waste on our beaches. Sainsbury's in Bude has agreed to remove single-use disposable BBQs from sale.

Campaign 2: Cheap Polystyrene Bodyboards are often not fit for purpose, breaking easily and releasing harmful polystyrene into the ocean, often considered single-use.

The Parish Council fully support these campaigns.

A few parishioners have voiced concerns over the condition of the bridge, with the growth of ivy and greenery which will potentially erode the stonework and cause issues
